<b>Pupils Travelling to the UK from abroad</b>	H	<p>-All pupils travelling to England must adhere to government travel advice and parents should bear in mind the impact on their child's education which may result from any requirement to quarantine or isolate upon return.</p> <p>-Those arriving from a 'red list' country or have transited through one in the past 10 days, must quarantine in a government approved facility with a parent or legal guardian rather than at home.</p>	- <a href="#">Travel abroad and coronavirus (COVID-19)</a> guidance to be shared with Staff and Parents/Carers where it is felt appropriate. <b>Asymptomatic Testing</b>	H	<p>-Primary age pupils will not be tested with LFDs. PHE have advised there are currently limited public health benefits attached to testing primary pupils with lateral flow devices.</p> <p>-Primary School age pupils presenting with symptoms of COVID-19 should have a PCR test.</p> <p>-Primary School age pupils should <b>not be</b> undertaking LFD tests at home.</p>		L	Headteacher

Use of <a href="#">Face Coverings</a> on the school site	M		-Due to the variants of COVID-19 - The current guidance continues to recommend in <b>all schools</b> that face coverings should be worn by staff and visitors outside of classrooms where social distancing is not possible (e.g. corridors). -In early years settings, it is still recommended that face coverings should be worn by staff and adults (including visitors) in situations where social distancing between adults is not possible. Children in early years settings should not wear face coverings. -Discuss with staff members if they wish to continue wearing face coverings in the classroom. -Discuss with Parents/Carers individual pupil concerns. -The requirement to wear face coverings in the classroom could be re-introduced in the event of local outbreaks, including variants of concern. Advice in terms of a decision on whether to wear face coverings or not could be sought from your Public Health contact.	L	Headteacher

<b>Wraparound provision and extra-curricular activity</b>	H	-Schools should be working to resume all before and after school activities and wraparound childcare. -Indoor provision can take place in groups of any number <b>-Minimise mixing of bubbles continue to keep children in consistent groups.</b>	-All parents may access wraparound (ie breakfast cub) and extra-curricular provision for their children, without any restrictions on the reasons for which they may attend. -Continue to work closely with wraparound providers to minimise mixing between pupils/children. -Providers should ensure that registers are maintained of pupils attending wrap-around/extra-curricular activities. -Keep children/pupils in consistent bubbles/groups. -Where providers are offering organised activities for children/pupils, such as extra-curricular activities are outdoors, this can currently happen in groups of any number. For example, if the activity is outdoors - regular handwashing/ sanitising; avoid touching objects shared by the public (e.g. a member of staff could hold a gate open to avoid everyone touching it); sanitising equipment before it is used; avoiding activities that require touching each other (e.g. holding hands).</p>
